**“SIX MONTHS ADVANCED CANCER CYTOGENETIC TRAINING COURSE”
COMMENCING FROM 01.03.2018 AT ACTREC**

Advanced Centre for Treatment, Research and Education in Cancer (ACTREC) announces a training course in Cancer Cytogenetic for Post-Graduates.

This training program will be focused on conventional cytogenetic and molecular cytogenetic areas of cancer cytogenetic. Cancer Cytogenetic Department is equipped with the state of the art instrumentation and expertise. The proposed course will cover theoretical, technical & practical aspects.

Selected candidates will be assigned to any one of the above as per requirement and In house examinations will be held periodically and certificates will be awarded to successful candidates on completion of the course in the specialty area.

DURATION	Six months, commencing from 01.03.2018 (6 Month's Training + 6 Month's Internship for Non-Sponsored)
QUALIFICATION	M.Tech. / M.Sc. from a State University with minimum 55% marks in Zoology / Medical or Biomedical Genetics / Botany / Microbiology / Biotechnology / Life Sciences / Cytogenetic. Candidates with 3-6 month's experience in Cytogenetic will be preferred.
NO. OF SEATS	3 (Three)
AGE LIMIT	Upto 30 Years (as on 31.01.2018) Relaxable for sponsored candidates and SC / ST & OBC as per rules.
COURSE FEES	Non-Sponsored Candidates : Nil Sponsored National Candidates : Rs. 12,000/- International Candidates : Rs. 21,000/-
STIPEND	Rs. 8,000/- (Rupees Eight Thousand Only) per month for non sponsored candidates for a period of six months. No stipend is admissible for Sponsored and International Candidates.
SECURITY DEPOSIT	Selected candidates are required to deposit an amount of Rs. 5,000/- (Rupees Five Thousand only) at the time of joining. The deposit will be refunded without interest on completion of the training course or after completion of the internship whichever is later. If trainee leaves the training at any time before completion of the training, deposit will stand forfeited.
SERVICE BOND	Selected Non Sponsored Candidates will be required to execute an agreement to serve the ACTREC w.e.f. 01.09.2018 on a consolidated remuneration @ Rs. 13,000/- p.m. (Rupees Thirteen Thousand only) for a period of six months after successful completion of the training. No Bond is required for Sponsored & International Candidates.

Hepatitis B Vaccination should be completed.

Accommodation will not be provided. A sum of Rs. 2,000/- p.m. (approx) will be charged towards diet charges, for which a sum of Rs. 4,000/- to be paid as a diet deposit.

Candidate shall pay the application fees of Rs. 250/- online by using Debit Card/Credit Card. **No other mode of payment will be accepted. Female, SC, ST and Physically handicapped candidates are exempted from paying of application fees. The application fees paid will not be refundable under any circumstances.**

HOW TO APPLY: Eligible candidates would be required to apply **ONLINE** through the link on our website viz. <http://actrec.gov.in> Last date for online application is **05.02.2018** upto 5.45 p.m. & receiving hard copy of online application is **09.02.2018**. No other mode of application will be accepted.

For applying Online, the candidates must possess valid email ID and a facility to take printout of the Acknowledgement Receipt. All correspondence with the applicant will be done through email only. Information regarding offer letters etc. will be provided through email. Responsibility of receiving, downloading and printing of related documents will be of the candidate. ACTREC will not be responsible for any problem of email sent, due to invalid/wrong email ID provided by the candidate or delivery of emails to spam/junk mail folder etc.

The candidate must submit a recent passport size photograph, attested copies of all certificates regarding Date of Birth, Educational Qualifications, Experience Certificates, Caste Certificate, Physically Handicapped Certificate etc. along with the hard copy of online application form so as to reach the **Senior Administrative Officer, ACTREC, Sector-22, Kharghar, Navi Mumbai 410210** on or before **09.02.2018**. Only committed applications will be accepted. The candidate will be responsible if the application is not committed online and submitted to ACTREC.

During the period of training, the Trainee shall not apply for any post or any other courses / P.G. studies / Scholarship or appear for any examination or interview outside.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates, as may be fixed by the centre. Those candidates who are found below expected standards with consistent poor performance in studies will be terminated from the training course.

Persons working under Central / State Government / Autonomous Body / Semi Government Organizations and other Public Sector Undertakings must forward their applications through (proper channel) the head of the organization.

Late & incomplete applications are liable to be rejected. No correspondence of any kind will be entertained.

Last date for receiving applications may be relaxed by two weeks in respect of candidates working or training abroad provided they send a PDF version of the complete application with all relevant attachments before the last date.

ACTREC reserves the right to restrict the number of candidates for interview to a reasonable limit on the basis of qualification and marks. Merely fulfilling the prescribed qualifications will not entitle an applicant to be called for the interview. ACTREC also reserves the right to reject any of the application without assigning any reason thereof.
