5	<b>ELIGIBILITY CRITERIA</b>	M.Sc. Nursing / B.Sc. Nursing /post Basic B.Sc. Nursing. Should be a registered nurse. Admissions open to male and female candidates. Experience in an oncology hospital for one year is desirable.
6	<b>REMUNERATION</b>	27000/- per month. No stipend for sponsored candidates.
7	<b>DRESS CODE</b>	Nursing uniform (white overcoat)
8	<b>ACCOMMODATION</b>	Hostel facility, subject to availability and rate will be as per TMC rules.
9	<b>CERTIFICATION</b>	The certificate will be awarded from Tata Memorial Centre, on successful completion of the fellowship.

11	<b>AGE LIMIT</b>	Upto 40 years as (on 15.07.2021) relaxable by 5 years for SC/ST & 3 years for OBC as per rules.
