Pipe (150 MM) cutting removing complete in all respect as per directed by EIC Pipe (150 MM) reinstallation testing & commissioning of existing pipe along with fitting, pipe supports, painting, support, nuts, bolts, washers, gaskets, elbow, tee, flanges, with fixing, welding, complete in all respect as per directed by EIC

2. Removing carefully of existing Mild Steel Tee junction of 300 MM which is connected to existing Two sides of Cast iron Pipes & one side of MS pipes. Supply of MS elbow of 300 MM. Supply of MS 300 MM Flange connector to elbow to MS Pipe Supply of Connector 300 MM from Flange connector to elbow to CI Pipe. Fixing of MS Flange MS Elbow & Connector (MS flange To Cast iron Pipe) testing it for all leakages & completing it in all respect as per direction of EIC.
3. Excavation & dismantling of concrete & casting PCC over required joints completing the work as per direction of EIC.

Payment Terms:

Payment shall be given for the work actually executed by the agency and the executed quantities items wise will billed after taking joint measurement between contractor and Engineer-in charge on completion of work. Payment term other than above mention will not be accepted.

Safety:

All the contractor's personnel working in ACTREC campus must follow safety norms and shall be complete with approved safety devices wherever a potential hazard , electrical hazards to personnel exists and with provision for safe access of personnel to and around equipment for operational and maintenance functions. The agency is required to provide First Aid Box with all accessories at suitable location during contract period.
