SCOPE OF WORK: -

- 1. Designs, Fabrication, supply & Installation of Stainless-Steel sink made out of SS 304 grade as per the site condition.
- 2. Contractor must approve design from Engineer In-charges before start of work.
- 3. The size mentioned in the tender drawing is for reference however agencies are requested to take actual site measurement before starting the fabrication works. All finished items are to be placed at respective places.
- 4. Scope of work includes Supply of material as per the site requirement, fabrication by welding, bolting & riveting as per approved design.
- 5. All material including consumables and non-consumables are in scope of Contractor.

Payment Terms:

Payment shall be given for the work actually executed by the agency and the executed quantities items wise will billed after taking joint measurement between contractor and Engineer-in charge. Payment term other than above mention will not be accepted. Payment will released 100 % after completion of work.

General Conditions:
