Scope of work:

- 1. The agencies are requested to visit site for detailed physical inspection and to understand the challenges, as the bulling is commissioned and there will be movement of Patients, Staff etc.
- 2. The area of work to be executed in the patient care building. The surrounding area is commissioned and there will be patients, relatives and public, staff movement. Extra care shall be taken while executing the work.
- 3. The work shall be executed in such a manner, it should not disturb the daily routine of Hospital works, and the day-to-day maintenance of other facilities.
- 4. Upmost care to be taken while shifting Material, Fabrication, cutting bending, and installing without damaging the installed sensitive equipment which are all in working conditions. Any damage to this equipment happens at the time of execution of work, the same shall be rectified at no extra cost to ACTREC.
