Scope of work:

- 2. Providing and erecting partitions (partly glazed /partly paneled or fully paneled) to required ht. with the teak wood frame as per instructions of the Engineer-in-Charge.
- 3. Providing making & supplying computer tables made out of 19mm commercial ply for tabletop, with all inner surfaces with 1mm thick approved laminate.
- 4. Providing & fixing cabinets made up of 19 mm commercial ply of approved make for the top, bottom, sides & shelves & 8mm commercial ply approved make for the backside.
- 5. Providing drawer units (movable with wheels) as per the description, drawing, and design in SOQR and to the satisfaction of the Engineer-in-Charge.
- **6.** Technical specifications as mentioned in the financial bid/BOQ shall be followed stringently.
- 7. The scope of work detailed above is indicative of the probable nature of the works only and the entire scope of work is not limited to the information furnished above.
- 8. Transportation of materials from the factory to ACTREC respectively, unloading, keeping the same at site appropriately, and placing as per the instructions of the Engineer-in-Charge.
- 9. All areas must be cleared from debris/ dismantled materials before a work completion certificate is issued for settlement of final payment. Bill will be settled as per the joint measurement for actual work done.
- 10. Once the order is issued, the agency is to contact the respective engineer-in-charge for administrative activities, challans, gate passes, submission of bills, any other site-related activities, etc.

- 11. The contractor shall provide all necessary measuring instruments materials, labours, tools, and plants required to execute the work.
- 12. The Contractor shall clean up and properly dispose of any excess materials and debris resulting from the work. The cost of cleanup and disposal shall be included in the cost of the various items.
- 1. The agency is requested to visit the site to know the actual scope of work.
- 2. Rate shall be basic and GST will be extra as applicable.
- 3. Material required at the site should be assessed by the agency and the bill will not be settled for excess/supplied items.
- 4. The bill will be settled as per actual measurement.
- 5. The agency will have to prepare a detailed drawing/ plan of work and obtain approval before execution. The agency will have time time-bound work schedule for carrying out the work.
- 6. The agency will have to give a guarantee of at least 1 year after completion of the project.
- 7. Payment will be released for the consumed quantity on satisfactory completion of providing necessary certifications/documentation.
- 8. All the above items of this schedule shall be standard and approved before installation.

Payment Terms:

Payment shall be settled based on work executed by the agency after raising RA bills. (Contractor has to forward their bills enclosing the challans duly endorsed at ACTREC security gate with receiver's signature).

Payment will be done as per actual joint measurement between the contractor and Engineer-in-Charge.

Safety:

All the contractor's personnel working in ACTREC campus must follow safety norms and shall be complete with approved safety devices wherever a potential hazard, electrical hazard to personnel exists and with provision for safe access of personnel to and around equipment for operational and maintenance functions. - 10)ACTREC reserves the right to terminate the contract immediately and without notice if the agency's work is deemed unacceptable. Any remaining work will be done at the agency's expense and risk. Before terminating the contract by ACTREC, one month's written notice will be given if it is no longer necessary.
