- 15. All areas must be cleared from debris/ dismantled materials before completion certificate is issued for settlement of final payment. Bill will be settled as per the joint measurement for actual work done.

- The quantities of various items as entered in the "BILL OF QUANTITIES" are indicative only
  and may vary depending upon the actual measurement. The Contractor shall be bound to

- The contractor shall provide all necessary measuring instruments material, labour, tools and plants required to execute the work.
- The Contractor shall clean up and properly dispose of any excess materials and debris resulting from the work out of ACTREC campus. The cost of cleanup and disposal shall be included in the cost of the various items while bidding and will not be paid separately.
