This course will cover both theoretical and practical aspects, including hands-on training in ECG and Holter monitoring. A certificate will be awarded to candidates who successfully complete the course.

1	<b>QUALIFICATIONS</b>	Candidates must be B.Sc. in paramedical or B.Sc. in life Sciences.
2	<b>AGE LIMIT</b>	Up to 40 years as on 01.06.2025 (Relaxable for sponsored candidates and SC/ST&OBC as per rules)
3	<b>NO. OF SEATS</b>	2 (Two seats)
4	<b>STIPEND</b>	<b>stipend @ ₹.8,000/-</b> per month (Rupees Ten Thousand Only) for a period of six months. Selected Candidates will be required to do mandatory Internship the Tata Memorial Centre-ACTREC <b>w.e.f. 01.02.2026</b> on a consolidated <b>remuneration @ Rs.12,000/-</b> per month (Rupees Twelve Thousand Only)  <b>*A trainee who fails to complete the training, will be liable to pay to the Institute(TMC-ACTREC) a sum equivalent to aggregate amount of stipend received by him/her during the period of training along with interest thereon.*</b>

#### **DETAILS OF THE COURSE:**

6	<b>DURATION OF THE COURSE</b>	1 Year Commencing from 1 <sup>st</sup> June 2025 (6months training and 6month internship)
7	<b>STRUCTURE OF THE COURSE</b>	Rotation across various work areas at ACTREC, including: A. A. Posting in the ECG Lab

		B. posting for Holter monitoring C. Rotational one month duty at Satya Sai Hospital. D. Posting in Echocardiography dept. to assist for procedure.
8	<b>OBJECTIVES</b>	At the end of the course, the student would be able to: A. Work as an ECG and Holter technologist at cardiology center, health checkup centers, under the supervision of doctors. They may also be employed in smaller hospitals within the cardiac department, functioning independently. B. Perform ECG tests and provide preliminary comments to doctors for diagnosis in all these areas, ensuring effective quality control, and deliver reliable reports to patients. C. Gain both theoretical knowledge and practical skills that will pave the way for further specialization in the field.
10	<b>EXAMS</b>	Candidates must score at least 50% in each individual theory and practical examination of the course to be considered successful.

Outstation candidate may be provided accommodation (Subject to availability) during the training period. They will have to pay accommodation charges as per institute policy.

**Terms & Condition:**

During the period of training, the trainee shall not apply for any other course/PG studies/scholarship or appear for any examination or interview outside without the permission of the center.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates fixed by the center. candidates whose performance in the course work is consistently found below expected standards will be terminated from the training course.

If more than 30 candidates apply for this position, a written examination will be conducted and the short listed candidates will be interviewed. Candidates will be selected based on performance in the interview.

Person working under central / State government, Autonomous body, Semi Government organizations and other public sector undertaking must submit no objection certificate from their present employer. ACTREC reserves the right to restrict the number of candidates for the interview to a reasonable limit on basis of qualification and marks. Merely fulfilling prescribed qualification will not entitle an applicant for the interview. TMC ACTREC also reserve the right to reject any of the applications without assigning any reason thereof.
