Stipend during Internship (06 month’s)	Selected Non Sponsored Candidates will be required to serve Bond period at the Tata Memorial Centre w.e.f. 01.08.2026 on a consolidated remuneration @ Rs.15,000/- p.m. (Rupees Fifteen Thousand Only) per month for B. O.Th candidates and Rs.18,000/- (Rupees Eighteen Thousand Only) per month for M. O.Th Candidates for a period of six months after successful completion of the training.
Accommodation	Hostel Accommodation will be provided on availability bases.
Security Deposit	Selected candidates are required to deposit an amount of Rs. 5,000/- (Rupees Five Thousand only) time of joining. The deposit will be refunded without interest on completion of the training course completion of the internship whichever is later. If trainee leaves the training at any time before completion of the training, deposit will stand forfeited.

During the period of training, the Trainee shall not apply for any post or any other courses/ P.G. studies / Scholarship or appear for any examination or interview outside.

Those candidates who are found below expected standards with consistent poor performance in studies will be terminated from the training course.
