Security/ Caution Deposit :

SENIOR RESIDENT - Rs.1,33,623/-

SR have to pay Security / Caution Deposit at the time of Joining **OR** the same will be deducted in **Five equal installments** from their salary. This deposit will be refunded without interest after completion of SRship/01 Year Fellowship.

- Residents may resign after completing five months of service, provided they give one month's notice (i.e., complete 6 months' total service). In such cases, they will be eligible for a refund of the deposit.
- If a Resident leaves the post without serving the required notice period, their last month's salary (30 days) will be forfeited.

Tata Memorial Centre reserves the right to cancel the posts, fix minimum eligibility standard / bench mark and restrict no. of candidates called for MCQ/Interview taking into account various factors like no. of vacancies, performance of the candidate etc., and decided to determine the qualifying marks for selecting candidates for the interview.
