Security/ Caution Deposit :

SENIOR RESIDENT - **Rs.1,33,623/-**

Senior Resident have to pay Security / Caution Deposit at the time of Joining **OR** the same will be deducted in **Five equal installments** from their salary. This deposit will be refunded without interest after completion of SRship. Residents may resign after completing five months of service, provided they give one month's notice (i.e., complete 6 months' total service). In such cases, they will be eligible for a refund of the deposit.

If a Resident leaves the post without serving the required notice period, their last month's salary (30 days) will be forfeited.
