Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates fixed by the center. candidates whose performance in the course work is consistently found below expected standards will be terminated from the training course.

If more than 30 candidates apply for this position, a written examination will be conducted and the short listed candidates will be interviewed. Candidates will be selected based on performance in the interview.

Actrec reserves the right to restrict the number of candidates for the interview to a reasonable limit on basis of qualification and marks.
